Eligibility:

The award is limited to Pakistani nationals only.

Criteria for consideration:

MH Qazi Excellence in Health Professions Education Award recipients will have made a significant impact in health professions education through outstanding contribution and dedication and exceptional performance in health professions education, as demonstrated by one or more of the following:

1. Outstanding achievements and performance:

The candidate demonstrates a substantial contribution to promoting health professions education in Pakistan and at the global level. These achievements are recognized in the form of high-quality publications, contributions to educational development, substantial impact on educational governance, policy and regulations and strengthening education as a profession and improving the quality of education at the national and global levels.

2. Professionalism:

The candidate consistently and substantially demonstrates high-quality professional standards and is recognized as a role model in health professions education. The candidate exhibits exceptional ability to foster collaboration, communication, and cooperation among colleagues and members of the health professions community.

3. Outstanding education support and initiative:

The candidate has significantly contributed to improving the education system in Pakistan through reforming the curricula and impacting the students' learning and assessment methods. The candidate consistently advocates health professions education at the national and international platforms.

4. Leadership, innovation and research:

The candidate has demonstrated leadership skills to enhance the dynamic nature of health professions education in Pakistan and globally. The candidate demonstrates a clear understanding of educational challenges in Pakistan and has shown the leadership skills to promote innovative changes in health professions education.

The candidate has the capacity to lead the profession and protect the interests of the profession through his/her leadership skills. The candidate should also validate his/her research skills through publications in high quality journals.

5. Continuing professional development and faculty development

The candidate provides evidence of his/her professional development and demonstrates substantial contribution for promotion of a professional development system.
